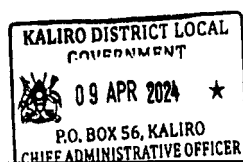

NOTE: A person shall not be entitled to be heard by the valuation court unless he or she had lodged a notice of objection within the stipulated time.
