(57) Abstract

A Grey Water Recovery and Gravity-Flush System for communal toilets is disclosed, designed to efficiently collect, store, and reuse grey water for flushing. The storage tank is constructed from durable, rust-proof materials such as stainless steel or high-strength plastic and has a variable capacity based on user demand.

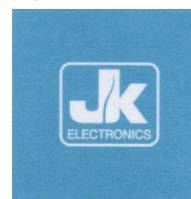

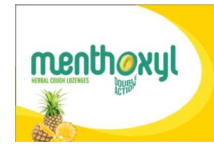

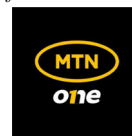
